MEMBERSHIP-PATRON/LIFE MEMBER/ACTIVITY WING
GENERAL GUIDELINES

1. The membership is open to all of age 18 years and above.
2. Those desirous of securing membership have to apply in the prescribed form .
3. The form duly completed and recommended by an existing member is to be given to the office along with the required registration fee.
4. Once the application is approved, the applicant will be notified when he/she will be required to pay the lump sum amount yearly subscription along with the interest free security deposit where applicable. The registration fee paid will be adjusted towards the admission fee.
5. The yearly subscription rate/security deposit/admission fee can be revised from time to time as determined by the Society.
6. The current rates of subscription etc. are :

Patron	Rs. 100000 (One time)
Life Member	Rs. 50000 (One time)
Corporate	Rs. 500000 (One time)
Subscription for Activity Wing	Rs. 400 (Yearly)
Registration fee/Admission fee	Rs. 100(One time)
Interest free Deposit for Activity Wing	Rs. 200 (One time, Six months subscription in force)
7. Annual subscription is payable in advance in April every year for members of Activity Wing.
8. Subscription once paid is not refundable.
9. Registration fee is not refundable in the event of not availing membership as and when allotted and notified.
10. Names of Activity Wing Members who fail to renew membership by paying the subscription amount due, will be removed at the end of six months (September) and their interest free deposit adjusted towards dues.
11. On admission a membership card will be issued. The card will be valid upto 31st March of the following year. Thereafter fresh membership cards will be issued every year on receipt of the yearly subscription and surrender of the old membership card. (Only the latter for Patrons & Life Members)
12. Loss of card should be intimated in writing to the office immediately. A duplicate card will be issued on payment of the prescribed fee (which is presently Rs. 15/-) Request for replacement of any subsequent loss of any subsequent loss of card will be entertained only against a payment of Rs. 100/-.
13. Change of address, telephone, fax etc. may kindly be notified to the office expeditiously. All communication will be sent to the last given address.
14. Admission to all programmes will be on presentation of valid membership cards.
15. Decision of the Board of Trustees/Managing Committee on all matters shall be final.
