**MEMBERSHIP -PATRON/LIFE MEMBER/ ACTIVITY WING/ASSOCIATE/NRI
GENERAL GUIDELINES**

1. The membership is open to all of age 18 years and above; for Associate Members the age limit is 15 to 25 years.
2. Those desirous of securing membership have to apply in the prescribed form .
3. The form duly completed and recommended by an existing member is to be given to the office along with the required registration fee. Plain paper applications may be made for Corporate & NRI Membership.
4. Once the application is approved, the applicant will be notified when he/she will be required to pay the lump sum amount or yearly subscription along with the interest free security deposit where applicable. The registration fee paid will be adjusted towards the admission fee.
5. The yearly subscription rate/security deposit/admission fee can be revised from time to time as determined by the Society.

7. Annual subscription is payable in advance in April every year for members of Activity Wing.
8. Additional discount of 10% for Members of Activity Wings who opt to receive all communications by Email only.
9. Subscription once paid is not refundable.
10. Registration fee is not refundable in the event of not availing membership as and when allotted and notified.
11. Names of Activity Wing Members who fail to renew membership by paying the subscription amount due, will be removed at the end of six months (September) and their interest free deposit adjusted towards dues.
12. Electronic Membership cards will be issued on admission and will renewed from time to time as applicable.
13. Loss of card or if damaged badly should be intimated in writing to the office immediately. A duplicate card will be issued on payment of the prescribed fee (which is presently Rs. 100/-)
14. Change of address, telephone, fax, email etc. may kindly be notified to the office expeditiously. All communication will be sent to the last given postal or email address.

15. Admission to all programmes will be on presentation of valid membership cards.
16. Decision of the Board of Trustees/Managing Committee on all matters shall be final.
17. Membership cards are not transferable for members of activity wings, associate & corporate members. Transfer may be considered under special circumstance for patrons, life members and NRIs with special conditions.
